AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF CUBA, MISSOURI, ON BEHALF OF SAID CITY, TO ENTER INTO AN AGREEMENT WITH CDG INC. FOR SERVICES RELATED TO ECONOMIC DEVELOPMENT ON BEHALF OF THE CITY

AGREEMENT WITH CUBA ECONOMIC DEVELOPMENT GROUP

This Agreement is given and made effective as of the date shown below by and between the Cuba Development Group Inc., a Public Benefit Corporation organized under 355 RSMO and the City of Cuba, Missouri, a Missouri city of the fourth class (“City”).

- A. Whereas The City believes it is in the best interest of the City of Cuba to support economic development within the City and desires to contribute financial support to the position of Executive Director for the Cuba Development Group, Inc for continued economic development within the City; and
- B. Whereas, the City believes it is in the best interest for the City of Cuba to have located within an office for economic development; and
- C. Whereas the Cuba Development Group, has requested assistance from the City in providing office space and financial support;.

According, in consideration of the above, and the mutual promises set forth below, the parties agree as follows:

- 1) The City shall pay to the Cuba Development Group Inc., forty thousand dollars (\$40,000.00) in equal monthly installments of three thousand three hundred thirty-three dollars and thirty-three cents. (\$3,333.33).
- 2) The City agrees to allow Cuba Development Group to have office space located within the City of Cuba’s Tourist Center as agreed upon by the parties.
- 3) Cuba Development Group shall authorize the president to perform tasks as assigned by the City of Cuba related to economic development on behalf of the City of Cuba.
