**AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF CUBA, MISSOURI, ON BEHALF OF SAID CITY, TO ACCEPT BID AND ENTER INTO AN AGREEMENT WITH M&L FARM SERVICES, LLC FOR HAY SERVICES AT THE CUBA TREATMENT PLANT, THE CUBA MUNICIPAL AIRPORT, AND BARNETT INDUSTRIAL PARK.**

**WHEREAS**, the Board of Aldermen of the City of Cuba, Missouri (City), has determined that it is in the best interests of the City to accept the bid of M&L Farm Services and enter an agreement with M&L Farm Services, LLC for hay services at the Cuba Treatment Plant, the Cuba Municipal Airport, and the Barnett Industrial Park.

**BE IT ORDAINED**, by the Board of Aldermen of the City of Cuba, Missouri, as follows:

**Section 1:** The City of Cuba, Missouri, shall accept the bid of M&L Farm Services and enter an agreement with M&L Farm Services, LLC for hay services at the Cuba Treatment Plant, the Cuba Municipal Airport, and the Barnett Industrial Park in Cuba, Missouri. A copy of said Agreement is attached hereto as Exhibit "A".

**Section 2:** The Mayor of the City of Cuba, Missouri, is authorized to execute the Agreement on behalf of the City.

**Section 3:** This ordinance shall be in full force and effect from and after its passage and approval.
