AN ORDINANCE APPROVING AWARDING THE BID FOR INSTALLING THE FENCING AT THE CUBA POLICE DEPARTMENT GUN FIRING RANGE TO ALL-TYPE FENCE INC. AND AUTHORIZING THE MAYOR TO SIGN ANY AND ALL DOCUMENTS NECESSARY TO AUTHORIZE THE CONSTRUCTION OF THIS PROJECT.

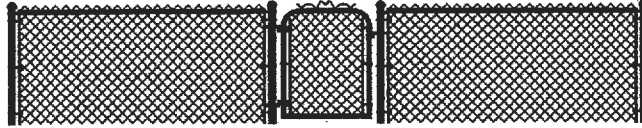

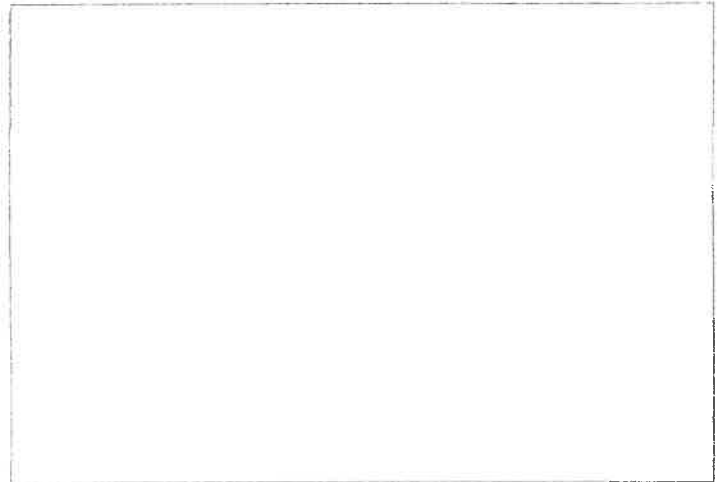
