SPECIAL ORDINANCE NO. _____

AN ORDINANCE APPROVING AWARDDING THE BID FOR RECOATING THE ROOF AT THE CUBA POLICE DEPARTMENT WITH A 10 YEAR WARRANTY TO RUDY'S ROOFING AND AUTHORIZING THE MAYOR TO SIGN ANY AND ALL DOCUMENTS NECESSARY TO AUTHORIZE THE CONSTRUCTION OF THIS PROJECT.

WHEREAS, the Board of Aldermen of the City of Cuba, Missouri (City) has determined that it in the best interest of the City to award the bid and enter into an agreement with Rudy's Roofing to recoat the roof at the Cuba Police Department.

Section 1: The City of Cuba, Missouri shall award the bid to Rudy's Roofing for recoating the roof at the Cuba Police Department with a 10 year warranty a cost of \$14,950.00 and authorizes the Mayor of the City of Cuba Missouri to execute any and all documents necessary to authorize the construction of this project.

Section 2: This ordinance shall be in full force and effect from and after its passage and approval.

3. For the 5 year option we only apply the white top coat over the existing roof

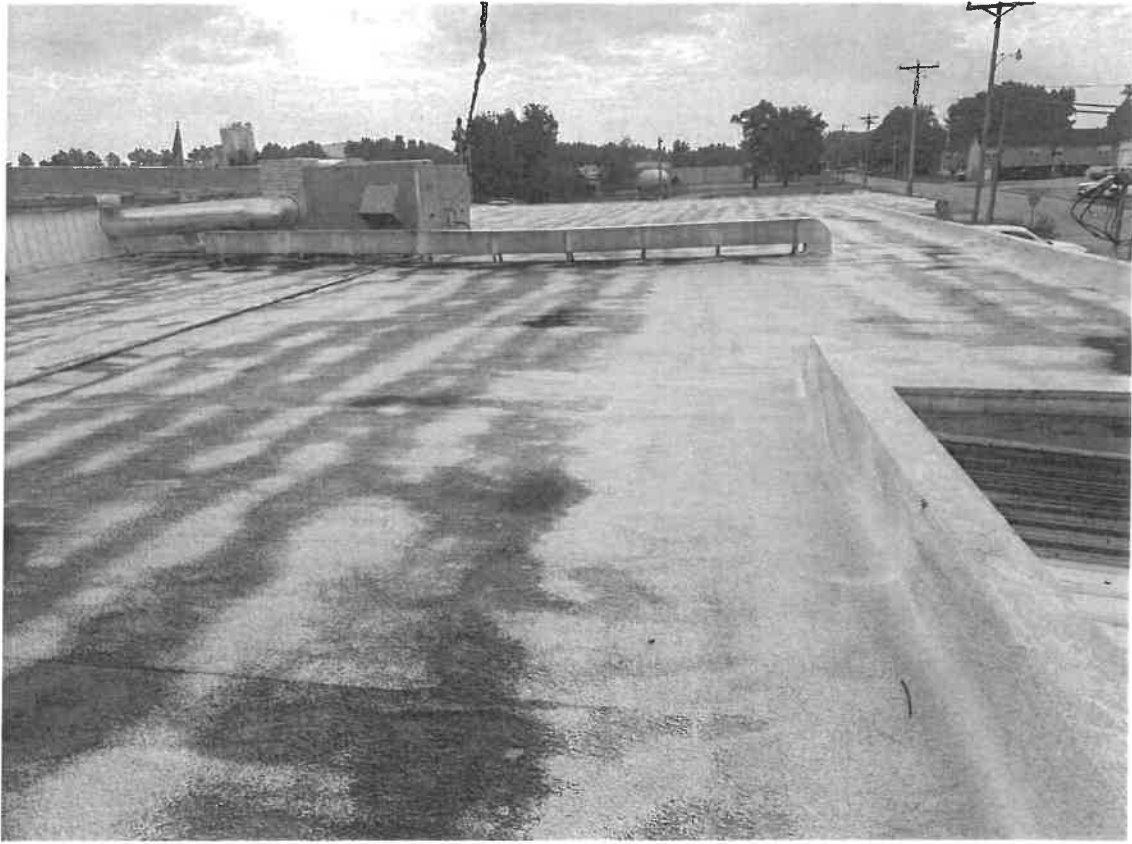
